I UNDERSTAND THAT THE PURPOSE OF SIGNING THIS DOCUMENT IS TO EXEMPT AND RELEASE EXCITOR FIJI LTD., THEIR OWNERS, HEIRS, EMPLOYEES, SALES AGENTS, AND ALL OR ANY OTHER ASSOCIATED PERSONNEL, AND THEIR EQUIPMENT AND BOATS (WHETHER OWNED, OPERATED, LEASED OR CHARTERED), HEREINAFTER REFERRED TO AS "RELEASED PARTIES", AND TO HOLD THESE ENTITIES HARMLESS FROM ANY AND ALL LIABILITIES, INJURIES OR DEATH ARISING AS A CONSEQUENCE OF THE FOLLOWING, OR ANY OTHER ACTS OR OMISSIONS ON THEIR PART, INCLUDING BUT NOT LIMITED TO NEGLIGENCE OF ANY TYPE.

2. I UNDERSTAND THAT I HAVE A DUTY TO EXERCISE REASONABLE CARE FOR MY OWN SAFETY AND ANY MINORS IN MY CARE, I AGREE TO DO SO.
3. I assert that I am physically fit to participate in all such water activities, including but not limited to snorkelling, swimming, riding on any and all vessels and I will not hold the Released Parties responsible if I am injured or die as a result of ANY problems (medical, accidental, or otherwise) which occur while snorkelling, riding vessels of all types, or otherwise participating in any Excitor Fiji Ltd.'s excursions.
4. I fully understand that the involved boat and associated vessels have limited medical facilities and that in the event of illness or injury appropriate medical care must be summoned by radio and treatment will be delayed until I can be transported to a proper medical facility. I agree in advance to these conditions.
5. The participating boat or any vessels have made no representation to me implied or otherwise that they or their crew can or will perform safe rescues or render first aid. In the event I show signs of distress or call for aid I would like assistance and will not hold the Released Parties, their crew, boats or passengers responsible for their actions in attempting the performance or rescue or first aid.
